



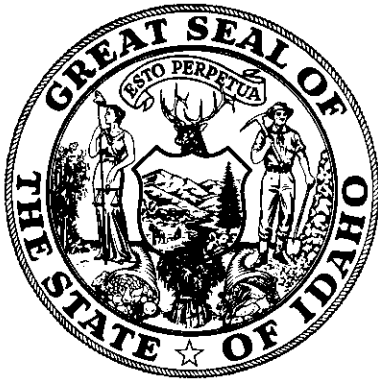

ARTICLES OF INCORPORATION

of

The undersigned incorporators, desiring to form a corporation pursuant to the provisions of the Idaho Business Corporation Act, Idaho Code 30-1-54 et seq. adopt the following Articles of Incorporation.

ARTICLE ONE - Name: The name of the corporation is Kerr Shelter Care, Inc.

ARTICLE TWO - Purposes: The purposes of the corporation are to engage in the care of people in a shelter care environment and to engage in any or all lawful business for which corporations may be organized under the Idaho Business Corporation Act.

ARTICLE THREE - Duration: The period of duration of the corporation is perpetual.

ARTICLE FOUR - Registered Office and Registered Agent: The address of the corporation's initial registered office in the State of Idaho is 653 East Center Street, City of Pocatello, State of Idaho 83205. The name of the corporation's initial registered agent at such address is M.B. Clark, Esq.

ARTICLE FIVE - Stock: The total authorized number of par value shares of stock is 250. The aggregate par value of the total authorized number of par value shares is Twenty Five Thousand Dollars (\$25,000.00).

ARTICLE SIX - Directors: The number of directors constituting the initial Board of Directors is four (4). The






