ARTICLES OF INCORPORATION

I, the undersigned person of the age eighteen years or more, as incorporator of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I

NAME

The name of this corporation is Master Craftsmen, Inc.

ARTICLE II

DURATION

The period of its duration is perpetual.

ARTICLE III

PURPOSES

This corporation is organized for the following reasons:

(A) To engage in any business, trade, or activity which may lawfully be conducted by a corporation organized under the Idaho Business Corporation Act.

(B) To engage in all such activities as are incidental or conducive to the attainment of the purposes of this corporation and to exercise any and all powers authorized or permitted to be done by a corporation under any laws that may be now or hereafter applicable or available to this corporation.

The forgoing clauses of this Article III shall be construed as purposes and powers, and the matters expressed in each clause shall be in no way limited or restricted by reference to or inference from the terms of any other clauses, but shall be regarded as independent purposes and powers; and nothing contained in these clauses shall be deemed in any way to limit or exclude any power, right or privilege given to this corporation by law or otherwise.

ARTICLE IV

SHARES

The aggregate number of shares the corporation will be authorized to issue is 10,000 shares with a par value of \$1.00 per share.

ARTICLE V

COMMENCEMENT OF BUSINESS

This corporation will not commence business until it has received its Certificate of Incorporation from the State of Idaho.

ARTICLE VI

DIRECTORS

The number of directors of this corporation shall be fixed by the bylaws and may be increased or decreased from time to time in the manner specified therein. The initial Board of Directors shall consist of two directors, and the name and address of the persons who shall serve as directors until the first annual meeting of the shareholders and until their successors are elected and qualified unless they resign or are removed are:

ARTICLE VII

BY LAWS

The Board of Directors shall have the power to adopt, repeal or amend the bylaws for this corporation subject to the power of the shareholders to amend or repeal such bylaws.

ARTICLE VIII

REGISTERED OFFICE, AGENT

ARTICLE IX

PREEMPTIVE RIGHTS

Preemptive rights shall not exist with respect to shares of stock or securities convertible into shares of stock of this corporation.

ARTICLE X

AMENDMENTS OF ARTICLES OF INCORPORATION

This corporation reserves the right to amend or repeal, by the affirmative vote of the holders of a majority of the shares entitled to vote thereon, any of the provisions contained in these Articles of Incorporation, and the rights of the shareholders of this corporation are granted subject to this reservation.
