ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS: That I, the undersigned, being a natural person of full age, citizen of the United States and resident of the State of Idaho, this day have voluntarily associated for the purpose of forming a corporation under and pursuant to the laws of the State of Idaho, and I do hereby certify as follows:

ARTICLE I

The name of the corporation shall be

Craig's Carpet & Upholstery Cleaning Inc.

ARTICLE II

The existence of this corporation shall be perpetual.

ARTICLE III

The principal office or place of business of this corporation shall be at 11704 W. Ginger Creek, Boise, Ada, Idaho 83713; but, the corporation may maintain an office in such towns, cities, or places inside and outside the State of Idaho as the Board of Directors may from time to time determine, or as may be designated by the By-Laws of said corporation. The registered agent shall be Craig N. Baxter; the registered office shall be at 11704 W. Ginger Creek, Boise, Ada, Idaho 83713.

ARTICLE IV

The purpose for which this corporation is organized is to include the transaction of any or all lawful business for which corporations may be incorporated under the laws of the State of Idaho.

ARTICLE V

The total amount of capital stock of this corporation is one hundred thousand dollars (\$100,000.00) and the number of shares into which it is divided is one hundred thousand (100,000) with a par value of one dollar (\$1.00) each. Of this total capital stock, one hundred thousand shares (100,000) with an aggregate value of one hundred thousand dollars (\$100,000.00) are common stock. No preferred stock will be claimed or issued.

ARTICLE VI

The members of the governing board of this corporation shall be styled "Directors", and the Board of Directors shall consist of not less than one (1) nor more than seven (7) members, as may be provided by the By-Laws of the corporation.


