TOfoster and encourage development and 22 implementation of professional standards of conduct of 23 individuals engaging in the conduct of private investigations 24 the operation of security companies; and promote to the 25 enactment of reasonable legislation regulating the conduct and 26 licensure of private investigators and security companies by 27 the State of Idaho; to promote, enhance, and regulate the
