ARTICLES OF INCORPORATION OF THE LEWIS-CLARK FLYING CLUB, INC.

We, the Undersigned, have associated, and do hereby associate ourselves together for the purpose of forming a corporation under Chapter 10 of Title 29 of the statutes of the State of Idaho.

I.

The name of this corporation shall be The Lewis-Clark Flying Club, Inc.

II

The purpose of this corporation shall be to promote and encourage aviation; to provide economical means for the engagement in aviation activities by its members; to develop and promote the dissemination of aeronautical information and matters of interest allied thereto; to furnish its members with facilities for regularly engaging in aeronautical activities; to encourage among the members of the corporation closer personal acquaintance, a friendly spirit of mutual cooperation; and to foster and cultivate the social, educational and business relationships among them; to broaden their interests in the pursuit of their vocations and avocations; and to forward and promote their general welfare, and thus to improve by any lawful and honorable means, the individual status and condition of each; also to provide surroundings for recreational facilities in the interest of the development of good moral character and a normal desire and ambition to improve themselves, and willingness to help others.

III

That, except as limited by law, the duration of this corporation shall be perpetual.

IV

The principal place of business and the registered office of the corporation shall be 517 Breier Bldg., Lewiston, Nez Perce County, Idaho, but offices may be established elsewhere as the directors may see fit.

This corporation shall have no capital stock and shall not engage in business for profit, and if any of the activities of the corporation result in income over and above the expenses, such income shall be used for purposes in accord with the stated aims of this corporation, and shall never inure to the benefit of, or be distributed to any individual member or members of the organization. The interests and rights of all members shall be equal, and no member can have or acquire a greater interest therein than any other member.

Except as limited by these articles, this corporation shall have and exercise all the powers granted to corporations by the laws of the State of Idaho, including the acquisition, ownership, sale, or trading, mortgaging and leasing of real and personal property, so long as such activities are engaged in to carry out the purpose of the organization.

VI

The officers by whom, and the manner in which the objects and purposes of this corporation shall be carried out, shall be as provided in the by-laws of the corporation, all natural persons of full age and at least 2/3 of whom are citizens of the United States,
