

The name of the corporation is Rowley Real Estate and Appraisal Service of Pocatello, Inc.

The duration of the corporation is perpetual.

III

The purpose of the corporation is to engage in any lawful act or activity for which a corporation may be organized under the Idaho Corporation Code.

IV

The corporation shall have the authority to issue ten thousand (10,000) shares of common stock, all of one (1) class, one hundred dollar (\$100) par value each, and ten thousand (10,000) shares of cumulative preferred stock with a ten percent (10%) annual interest feature, one hundred dollar (\$100) par value each. No capital stock shall be transferred or sold without offering it first to the corporation and then to the other stockholders on the same terms contained in any offer.


