ARTICLES OF AMENDMENT OF ARTICLES OF INCORPORATION OF THE POST COMPANY

We, the undersigned, J. M. Brady, President, and J. Robb Brady, Secretary-Treasurer, of The Post Company, an Idaho corporation, do hereby certify:

That on March 18, 1966, the following amendments to the Articles of Incorporation of The Post Company were adopted with the unanimous written consent of all shareholders of all issued and outstanding stock of this corporation entitled to vote.

RESOLVED: That the Articles of Incorporation of The Post Company be amended as follows:

1. Article II of the Articles of Incorporation, as amended, is repealed and the following Article is adopted to replace it:

ARTICLE II

The corporation shall have perpetual existence.

2. Article VII of the Articles of Incorporation, as amended, is repealed and the following Article is adopted to replace it:

ARTICLE VII

The board of directors by a majority vote shall have the power to repeal and amend the by-laws and to adopt new by-laws.

3. Article VIII of the Articles of Incorporation, as amended, is repealed and the following Article is adopted to replace it:

ARTICLE VIII

The board of directors shall consist of five-directors,

but during their term of office or thereafter, the number of directors may be increased or decreased from time-to-time, as may be provided by the by-laws; provided, however, that the number of directors shall not be less than three.

4. Article X of the Articles of Incorporation, as amended, is repealed and the following Article is adopted to replace it:

ARTICLE X

These Articles of Incorporation, as amended may be amended in the manner provided under the laws of the State of Idaho relating to business corporations, including any present and future amendments thereto.
