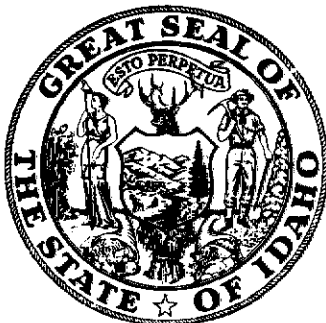

The undersigned natural persons, each more than eighteen (18) years of age, hereby establish a professional service corporation pursuant to the statutes of Idaho, and adopt the following Articles of Incorporation:

1. NAME. The name of the corporation is

SWORD PAINTING COMPANY, INCORPORATED.

2. DURATION. Perpetual.

3. PURPOSE AND POWERS. (a) The Corporation is organized for the general purpose of participating in the construction industry in all departments, including general contracting or specialty contracting such as painting, cement work and all other phases of the construction industry, including the manufacturing of equipment which is associated with the performance of construction contracts. The Corporation shall have the ability and right to enter into public works contracts.

(b) The Corporation may exercise the powers and privileges now or hereafter conferred upon corporations by Idaho law.

4. QUALIFICATIONS OF SHAREHOLDERS. There shall be no qualification requirements to be a shareholder in this Corporation.

5. AUTHORIZED SHARES. The aggregate number of shares which the Corporation shall have authority to issue is 1,000 common shares, each being without par value.

6. VOTING. Each shareholder of record shall have one vote for each share of stock standing in his name on the books of the Corporation. Cumulative voting for the election of directors is permitted.

7. PURCHASE OR TRANSFER UPON INELIGIBILITY. Within thirty (30) days after any shareholder ceases to be eligible to be a shareholder, the Corporation shall purchase all of the shares he owns or such shares shall be transferred to a qualified person as described in Article 4. The price to be paid by the Corporation and the schedule of payments shall be as specified in the By Laws, and if no price or schedule is so specified, the price shall be the pro rated net book value thereof as of the last day of the month preceding the date of purchase and payment shall be made in cash against receipt of the shares.

8. LIABILITY. The shareholders and officers of the Corporation shall have all of the liability protection provided by Idaho law.

9. INITIAL DIRECTORS. Three directors shall constitute the initial board, their names and addresses being as follows:

No person may be simultaneously an officer, director, or shareholder of more than one (1) professional corporation. A professional corporation which has only three (3) shareholders need have only three (3) directors, who shall be such shareholders. The three (3) shareholders shall fill all of the general offices of the Corporation between them. A retired person may not continue as a director, officer or shareholder of this Corporation.

10. MANAGEMENT OF CORPORATION. The business and affairs of the Corporation shall be managed by the shareholders of the Corporation and the Board of Directors.

The Board shall be authorized to manage only so much of the business and affairs of the Corporation as shall from time to time be delegated to it by the shareholders by means of By-Laws or otherwise.

The right to amend or repeal the By-Laws and to adopt new By-Laws is reserved to shareholders.

11. ADDRESS. The address of the initial registered office of the Corporation is 2101 N. 2300 E., Twin Falls, Idaho. The name of its initial registered agent at such address is Nancy Sword.

12. CERTIFIED COPY. A copy of these Articles and all amendments thereto in each case certified by the Secretary of State shall be filed with the Clerk of the Supreme Court of the State of Idaho.

13. SUBCHAPTERS. Whenever the Corporation shall have in effect a valid election, neither terminated nor revoked, to be taxed pursuant to Subchapter S of the Internal Revenue Code of 1954, or any amendment thereof, no attempted transfer or hypothecation, voluntary or involuntary (including any caused by the death of a shareholder), of any stock of the Corporation shall be effective unless and until the proposed transferee shall have timely executed and delivered any consent or other documents required to maintain in full force and effect such election.

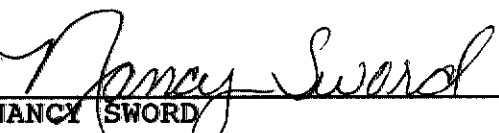
