KNOW ALL MEN BY THESE PRESENTS, that the undersigned 98 FEB 25 AM 8 55 incorporators being of the age of eighteen years or more, desiring to organize a corporation under the laws of the State of Idaho, do hereby make, sign and verify these Articles of Incorporation.

# ARTICLE I

The name of the Corporation is W.E.C.O., Inc...

# ARTICLE II

The period of its duration is perpetual.

#### ARTICLE III

The purposes for which the Corporation is organized are:

For public and private transportation of all kinds, including transportation of commodities & goods of any kind or description.

For the transaction of any or all lawful business for which corporations mayt be incorprated under the Idaho Business Corportation Act, Idaho Code \$30-1-1, et seq.

#### ARTICLE IV

The Corporation is authorized to issue one class of shares, in a total amount of 300 shares, each share of stock bearing a par value of \$100.00. Shares of stock of this Corporation shall not be transferred or sold unti said sale shall be approved by the Board of Direcotrs of this Corporation, in accordance with the duly adopted By-Laws of this Corporation.
