ARTICLES OF INCORPORATION

The period of its duration is perpetual.

ARTICLE V

This corporation shall have a management vested in the Board of Directors, consisting of four directors. The corporate powers, business and property of this corporation shall be exercised, conducted and controlled by a board of four directors.

The amount of authorized capital stock in this corporation shall be \$250,000.00, divided into 100 shares of par value of \$2,500.00 per share. No distinction shall exist between the shares of this corporation, or the holders thereof.

ARTICLE VII

All of the incorporators subscribed hereto are of full age and are citizens of the United States.

ARTICLE VIII

This organization shall have powers to lease, purchase, hold, and sell or convey property and to enter into any business transaction necessary for corporation purposes.

ARTICLE IX

Officers and Directors of this organization shall be elected by the members at the annual meeting. The number of officers and directors and all other matters relating to the management of the corporation shall be set out in the bylaws.

ARTICLE X

The undersigned incorporators shall act as and shall constitute the initial Board of Directors until the first annual meeting and election is held.

ARTICLE XI

These Articles may be altered and amended at any meeting of the organization providing a quorum is present, by a majority voted of the members present at such meeting.
