ARTICLES OF INCORPORATION

OF

D R, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of this corporation is D R, INC.

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The purpose or purposes for which the corporation is organized are: to carry on the business of real estate sales, purchases, management, any lawful activity related to these businesses and the transaction of any or all other lawful business for which a corporation may be incorporated under the Idaho Business Corporation Act.

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is 10,000 with no par value.

ARTICLE V

There are no provisions denying preemptive rights.

ARTICLE VI



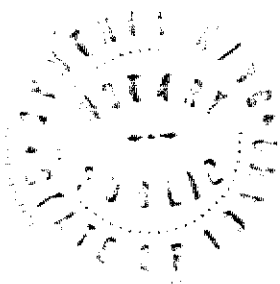
