ARTICLES OF INCORPORATION

OF

THE TIMES PUBLISHING COMPANY, LIMITED.

KNOW ALL MEN BY THESE PRESENTS:

That we, Bert. P. Mill, S.E. Mill, and W.J. McCulley, citizens of the
United States, residents of the State of Idaho, have this day
associated ourselves together for the purpose of incorporating, under
the laws of the State of Idaho, and in the manner therein described, to-
wit; and we hereby certify:

First. That the name of said Corporation, shall be The Times Publishing
Company, Limited.

Second. To do a general newspaper, printing, publishing and binding bus-
iness of all kinds, including any and all matters incident to, necessary
for and growing out of the same.

Third. That the place where the principal business of said Corpo-
ration shall be transacted shall be, in the City of Idaho Falls, County of
Bingham and State of Idaho.

Fourth. That the term for which said corporation shall exist is Fifty
years.

Fifth. That the number of directors of said corporation shall be
Three, and shall be stockholders of said Corporation, and shall be elected
in the manner provided by law.

Sixth. The amount of Capital stock of said Corporation, shall be
Ten Thousand (\$10,000.00) Dollars, divided into ten thousand shares at the
per value of One (\$1.00) Dollar each.
