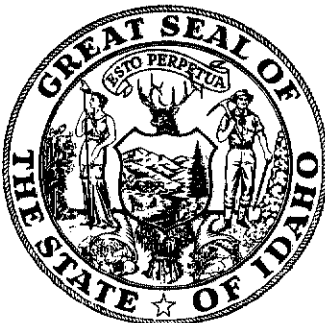

**ARTICLES OF INCORPORATION  
4 SEASONS AUTO SALES, INC.  
UNDER THE IDAHO BUSINESS CORPORATION ACT**

It is hereby certified that:

1. The name of the proposed corporation is 4 SEASONS AUTO SALES, INC.
2. The period of duration of the corporation shall be perpetual.
3. The purposes for which this corporation is formed, are as follows, to wit:  
To carry on the business of selling cars and to do all things necessary and related thereto; and to transact any or all lawful business for which corporations may be incorporated under the IDAHO BUSINESS CORPORATION ACT.
4. The aggregate number of shares which the corporation shall have the authority to issue is ONE THOUSAND (1000) common shares without par value.
5. The shareholders shall not have preemptive rights to acquire unissued or treasury shares or securities convertible into such shares.
6. Shares of the corporation may not be sold or transferred by the corporation or any holder of shares of the corporation to any person without the unanimous consent of the board of directors of the corporation.
7. The address of the initial registered office of the corporation is 4 SEASONS AUTO SALES, INC., 195 S. Skyline Dr., Idaho Falls, Idaho 83402; and the name of the registered agent is Lewis Ehardt, Jr.
8. The initial board of directors of the corporation shall consist of TWO (2) members, who shall serve as directors until the first annual meeting of shareholders or until their successors are elected and qualify; the names and addresses of the persons serving as initial directors are the same as the incorporators listed in Article (9).
