ARTICLES OF INCORPORATION

OF

BENNETT LUMBER PRODUCTS, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, natural persons of the age of 21 YEARS OR MORE, CITIZENS OF THE UNITED STATES. ACTING AS INCORPORATORS UNDER THE LAWS OF THE STATE OF IDAHO, ADOPT THE FOLLOWING ARTICLES OF INCORPORATION FOR BENNETT LUMBER PRODUCTS, INC.

I. NAME

THE NAME OF THIS CORPORATION IS TO BE BENNETT LUMBER PRODUCTS, INC.

II. PURPOSES

THE PURPOSES FOR WHICH BENNETT LUMBER PRODUCTS. INC. IS INCORPORATED ARE AS FOLLOWS:

- To GENERALLY ENGAGE IN, DO AND PERFORM ANY ENTERPRISE, ACT OR VOCATION THAT A NATURAL PERSON MIGHT OR COULD DO OR PERFORM.
- To manufacture, produce, purchase or otherwise acquire, TO MORTGAGE, PLEDGE, SELL, ASSIGN AND TRANSFER, OR OTHERWISE DISPOSE OF, IMPORT, EXPORT, DISTRIBUTE, INVEST, TRADE, DEAL IN AND WITH, EITHER AS PRINCIPAL OR AGENT, GOODS, WARES, MERCHAN-DISE AND MATERIALS OF EVERY KIND OR DESCRIPTION WHETHER NOW KNOWN OR TO BE HEREAFTER DISCOVERED OR INVENTED, INCLUDING BUT NOT LIMITED TO PERSONAL PROPERTY, AND INCLUDING BUT NOT LIMITED TO EVERY KIND, CLASS AND DESCRIPTION.
- *3*. TO ENGAGE IN, DO AND TRANSACT A LUMBER, BUILDING MATERIALS AND FOREST PRODUCTS BUSINESS IN ANY AND ALL OF ITS

BRANCHES; TO BUY OR OTHERWISE ACQUIRE AND SELL OR OTHERWISE

DISPOSE OF, AND IN ANY MANNER DEAL IN, WITH, AND PROCESS TREES, LOGS, LUMBER, TIMBER, WOOD AND THE PRODUCTS OF FORESTS, OF ANY AND ALL KINDS, AND THE CHEMICAL COMPONENTS THEREOF, IN ANY AND ALL STATES, IN ANY FORM OR CONDITION, WHETHER FELLED, STANDING OR GROWING, AND IN ANY AND ALL WORKED, BUILT, MANUFACTURED OR MADE SHAPES, ARTICLES OR STRUCTURES. TO PUR-CHASE, OR OTHERWISE ACQUIRE, BUILD, CONSTRUCT, OWN, HOLD, TAKE ON LEASE, RENT, USE, OPERATE, LEASE, LET, SELL, CONVEY, MORTGAGE, OR OTHERWISE DISPOSE OF, AND IN ANY MANNER DEAL IN AND WITH LANDS, TIMBER, LOGGING OPERATIONS, LUMBER MILLS, SAW MILLS, PLANING MILLS, KILNS AND OTHER WORKS, MACHINERY, PLANTS AND EQUIPMENT FOR HARVESTING, SAWING, PLANING, VENEERING, DRY-ING AND PROCESSING WOOD, FOREST PRODUCTS, AND LUMBER PRODUCTS; FELLING, HAULING OR OTHERWISE TRANSPORTING, CUTTING, DRESSING, TREATING, WORKING AND HAULING TREES, LOGS, LUMBER, TIMBER, WOOD, FOREST PRODUCTS, IN ANY AND ALL FORMS AND FOR ANY AND ALL PURPOSES. TO BORROW OR RAISE MONEY FOR ANY OF THE PUR-POSES OF THE CORPORATION AND FROM TIME TO TIME.
