ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
NORTHWEST THERMOCOUPLE, INC.

Pursuant to the provisions of Sections 30-1-59 to 30-1-63 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is Northwest Thermocouple, Inc.

SECOND: The following amendments to the Articles of Incorporation were adopted by the shareholders of the corporation on June 14, 1991, in the manner prescribed by the Idaho Business Corporation Act:

The name of the corporation is changed from Northwest Thermocouple, Inc. to TECATE ASSEMBLY SERVICES, INC.

THIRD: The number of shares of the corporation issued and outstanding at the time of such adoption was 7,865; and the number of shares entitled to vote thereon was 7,865.


FOURTH: The number of shares voted for such amendment was 7,865; and the number of shares voted against such amendment was zero.
