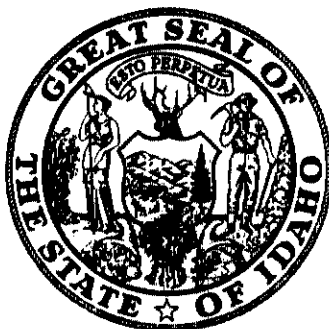
### CERTIFICATE OF AMENDMENT OF
