### DESCRIPTION OF PROPOSED CITY LIMITS OF GREENLEAF, IDAHO

A tract of land in Sections 21 and 22 of Township 4 North, Range 4 West of the Boise Meridian in Canyon County, Idaho, more particularly described as follows:

Beginning at the North  $\frac{1}{4}$  corner of Section 21, Township 4 North, Range 4 West of the Boise Meridian, the INITIAL POINT OF THIS DESCRIPTION;

thence North  $89^{\circ} 34'$  East 1320.40 feet along the North line of said Section 21, to the Northeast corner of the Northwest  $\frac{1}{4}$  of the Northeast  $\frac{1}{4}$  of said Section 21;

thence South  $00^{\circ} 38'$  West 317.00 feet to the Northerly right of way line of the Union Pacific Railroad property and the intersection with a curve to the right in the said right of way line, having a central angle of  $54^{\circ} 53'$  and a radius of 2694.58 feet;

thence along said curve 1326.83 feet to the end of said curve;

thence South  $35^{\circ} 43'$  East 1119.20 feet along the said Northerly right of way line to the beginning of a curve to the left having a central angle of  $54^{\circ} 40'$  and a radius of 1387.69 feet;

thence along the arc of said curve 368.14 feet, more or less, to the intersection of the said Northerly right of way line with the centerline of Renshaw Canal;

thence South  $16^{\circ} 19'$  West 651.03 feet, more or less, along the centerline of Renshaw Canal;

thence South  $89^{\circ} 50'$  West 362.75 feet to <sup>a point on</sup> the East line of Section 21, which is 330 feet South of the East  $\frac{1}{4}$  corner of said Section 21;

thence South  $89^{\circ} 30'$  West 2653.11 feet <sup>parallel to the East-West Centerline of said Sec. 21</sup> to the East line of the Southwest  $\frac{1}{4}$  of Section 21, Township 4 North, Range 4 West of the Boise Meridian;

thence South  $1^{\circ} 04'$  East 329.50 feet along the said East line of the Southwest  $\frac{1}{4}$  of Section 21, to the Southeast corner of the Northeast  $\frac{1}{4}$  of the Northeast  $\frac{1}{4}$  of the Southwest  $\frac{1}{4}$  of said Section 21;

thence South  $89^{\circ} 30'$  West 1334.92 feet/ along the South line of the North  $\frac{1}{2}$  of the North  $\frac{1}{2}$  of the Southwest  $\frac{1}{4}$  of said Section 21 to the centerline of a drain ditch;

thence North  $21^{\circ} 30'$  West 707.03 feet along the centerline of said ditch to the centerline of Highway 19;

thence North  $89^{\circ} 30'$  East 253.7 feet along the centerline of Highway 19;

thence North  $0^{\circ} 29'$  West 330.00 feet;

thence North  $39^{\circ} 30'$  East 252.20 feet;

thence North  $0^{\circ} 29'$  West 2314.30 feet parallel to and 476 feet West of the North-South centerline of said Section 21, to a point on the North line of said Section 21;

thence North  $89^{\circ} 41'$  East 476.00 feet along the said North line to the North  $\frac{1}{4}$  corner of said Section 21, the INITIAL POINT OF THIS DESCRIPTION.
