#### ARTICLES OF INCORPORATION

OF

WEST GRAIN, INC.



#### KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, all full-age citizens of the United States and of the State of Idaho, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and to that end do hereby adopt Articles of Incorporation as follows:

#### ARTICLE I.

Corporate Name

The name of this corporation shall be West Grain, Inc.

#### ARTICLE II.

Place of Business

The said corporation is organized at, and the place of its general business shall be at Soda Springs, Caribou County, State of Idaho.

## ARTICLE III.

# Period of Existence

The existence of said corporation shall be perpetual or until otherwise dissolved or disincorporated, pursuant to law.

# ARTICLE IV.

## Corporate Purposes

The purposes, objects and powers of said corporation are as follows, to-wit:

- 1. To own and operate a bonded warehouse.
- 2. To buy and sell grain and other farm produce for cash or on credit.
- 3. To buy and sell seed, feed, fertilizer and other farm supplies, at wholesale or retail, for cash or on credit.

- 4. To provide services of all types to farms and farmers, for cash or on credit.
- 5. To buy, sell, mortgage or otherwise deal in real or personal property in any manner that may be necessary or desireable in carrying out the other purposes and objects of this corporation.
- 6. To have any other statutory powers granted by law to general business corporations.

# ARTICLE V.

# Capital Stock

The capital stock of this corporation shall consist of 500 shares of stock with a par value of \$100.00 per share for a total authorized capitalization of \$50,000.00. All of the capital stock of this corporation shall be common stock and shall be non-assessable.
