**ARTICLES OF AMENDMENT  
to the  
ARTICLES OF INCORPORATION  
of  
DISCHOTEL, INC.**

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation, DiscHotel, Inc., by agreement of the stockholders by an Agreement in Lieu of Special Meeting of the Stockholders of DiscHotel, Inc., adopts the following Articles of Amendment to its Articles of Incorporation:

**FIRST:** Paragraph III of the Articles of Incorporation shall be amended to read as follows:

That the registered office of this corporation and the principal place for transaction of its business is hereby designated as 4595 Savannah Lane, Boise, Idaho 83703. The registered agent of this corporation and his address is Darrell Hansen, 4595 Savannah Lane, Boise, Idaho 83703.

**SECOND:** Paragraph VI of the Articles of Incorporation shall be amended to change the number of capital stock authorized to be issued by the corporation from "1,000 shares" to "10,000,000 shares", to read as follows:

The total number of shares of stock which the corporation shall have the authority to issue shall be ten million shares of common stock, all of one class, of the par value of One Dollar (\$1.00) per share. Each share of common stock shall have the same rights, privileges and voting powers and the same shall be fully paid and non-assessable. Said shares shall not have pre-emptive rights.

By such minutes of a special meeting, the President and Secretary were instructed to cause Articles of Amendment to be prepared, sworn to and filed as required by law to accomplish the amendment of the Articles in accordance with the agreement of the stockholders.


