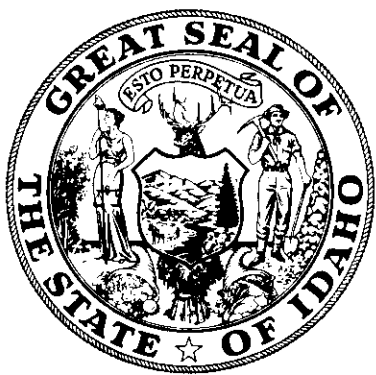

RECEIVED STATE ARTICLES OF INCORPORATION

OF

THE IDAHO FALLS YOUTH HOCKEY ASSOCIATION, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Non-profit Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is The Idaho Falls Youth Hockey Association, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are:

To promote amateur hockey in the Idaho Falls area of the State of Idaho in accordance with the goals and aims of the Amateur Hockey Association of the United States and pursuant to the goals and aims of this corporation.

To promote good sportsmanship, enhancement of ice skating skills, development of hockey skills and competitive play.

To combine and unite the efforts of amateur youth hockey within the local area of Idaho Falls, Idaho and its environs.

To operate in conjunction and in cooperation with the Amateur Hockey Association of the United States.

FOURTH: The corporation shall consist of members as provided by the By-Laws. The management of the corporation shall be vested in its Board of Directors.




