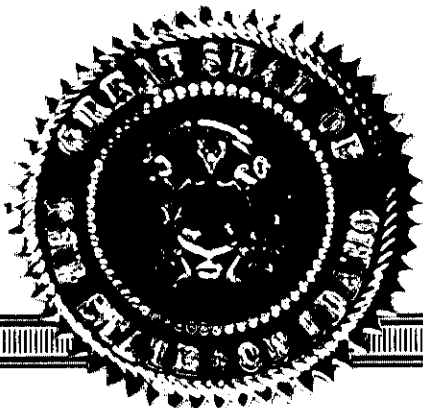

ARTICLES OF INCORPORATION  
OF  
VIVA-TU Inc.

The undersigned natural person of the age of eighteen (18) years or more, acting as incorporator of a corporation under the Idaho Business Corporation Act, does hereby adopt the following Articles of Incorporation.

ARTICLE ONE

The name of the corporation is VIVA-TU INC.

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
