The undersigned, acting as incorporator of a corporation under the Idan Business *

Corporation Act, adopt the following Articles of Incorporation for such corporation:

- 1. NAME: The name of the corporation is P & H, INC.
- 2. **DURATION**: The period of it's duration is perpetual.
- 3. **PROFIT**: This is a profit corporation.
- 4. <u>PURPOSES</u>: The purpose or purposes for which the corporation is organized is for the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
