Block 5 on your annual report must be completed to show the nature of business of the corporation. Saying that you are a non-profit corporation is too broad. Please be more specific.

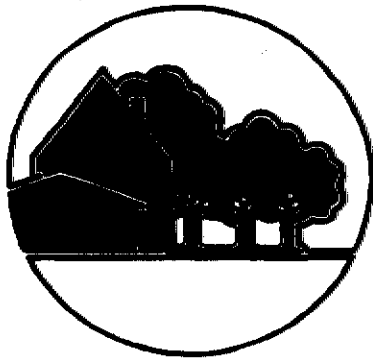
