KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned, Chester W. Ferguson & Beverly A. Ferguson, being natural persons of full age, and citizens of the United States of America, do hereby form a corporation pursuant to the Idaho Business Corporation Act, and we do hereby certify, declare and adopt the following Articles of Incorporation:

I.

The name of the corporation shall be FERGASON ENTERPRISES, INC.

II.

The period of existence and duration of the life of this corporation shall be perpetual.

III.

The location of the registered office of this corporation shall be 407 Foster Street, Cottonwood, Idaho 83522 and the address of the registered office of the corporation shall be P. O. Box 341, Cottonwood, Idaho 83522 and the registered agent at this address is Chester W. Ferguson.

IV.

The nature of the business and the objectives and purposes to be transacted, promoted and carried out are to do any or all things herein mentioned as fully and to the same extent as natural persons might or could do, and in any part of the world, viz:

To carry on and conduct the business of food and lodging, beauty and barber shops, and to transact any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

V.

The Capital Stock of this corporation shall be \$25,000.00 divided into 2,500 shares of stock at par value of \$10.00 each. No distinction shall exist between shares of this corporation and all such shares shall have the same right in the corporation.
