

ARTICLES OF DISSOLUTION
OF
ALTERNATIVES OF EASTERN IDAHO, INC.
An Idaho Nonprofit Corporation

Pursuant to the Idaho Nonprofit Corporation Act, the undersigned corporation has adopted the following Articles of Dissolution for the purpose of dissolving the Corporation:

FIRST: The name of the corporation is Alternatives of Eastern Idaho, Inc., and its address is 814 Masters, Idaho Falls, Idaho.


FIFTH: All remaining property and assets of the Corporation have been distributed in accordance with the Articles of Incorporation.

(the "Corporation") that the Corporation should be dissolved; and that the Resolution of the Board of Directors regarding dissolution of the Corporation be hereby endorsed and ratified, and Articles of Dissolution be filed with the Idaho Secretary of State.




