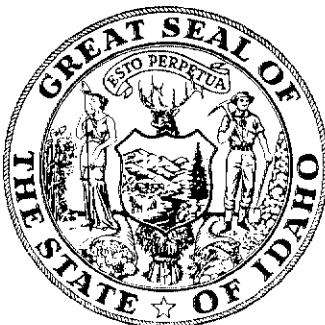

**ARTICLES OF INCORPORATION
OF
HUCKLEBERRY PRESS, INC.**

THE UNDERSIGNED, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is HUCKLEBERRY PRESS, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is Three Hundred (300) shares common stock with a par value of \$100.00 per share.

FIFTH: The address of the initial registered office of the corporation is 201 Arizona Street, Gooding, Idaho 83330, and the name of its initial registered agent at such address is Mike R. Reed.
