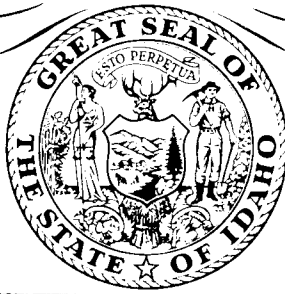

CERTIFICATE OF AMENDMENT OF ARTICLES OF INCORPORATION

I, ARNOLD WILLIAMS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the

NORTH IDAHO PROPERTIES, INC.

a corporation organized and existing under and by virtue of the laws of the State of Idaho, filed in this office on the **Twenty-fifth** day of **June**, 19 **65**, original articles of amendment, as provided by Section **30-146, 30-147 and 30-148, Idaho Code**, increasing authorized capital stock to **\$800,000.00**, divided into **80,000** shares common stock of par value of **\$10.00 per share**,

and that the said articles of amendment contain the statement of facts required by law, and ~~are~~ ^{will be} recorded on ~~film No.~~ **microfilm** of Record of Domestic Corporations of the State of Idaho.

I THEREFORE FURTHER CERTIFY, That the Articles of Incorporation have been amended accordingly.

AMENDMENT
of
ARTICLES OF INCORPORATION
of
NORTH IDAHO PROPERTIES, INC.

WHEREAS, at a special meeting of the stockholders of NORTH IDAHO PROPERTIES, INC., duly called and held in the City of Coeur d'Alene, State of Idaho, on the 7th day of June, 1965, at 10:00 o'clock, a.m., at which meeting all of the shares of the capital stock of said corporation issued and outstanding were represented in person, the following resolution was adopted by unanimous vote of the said issued and outstanding stock:

RESOLVED, That Article V of the Articles of Incorporation of NORTH IDAHO PROPERTIES, INC., be and the same hereby is amended to read as follows:

"ARTICLE V.

The total authorized number of par value shares including those previously authorized is 60,000. The aggregate par value of the total authorized number of par value shares is \$600,000.00. "

RESOLVED FURTHER That Article Vi of the Articles of Incorporation of NORTH IDAHO PROPERTIES, INC., be and the same hereby is amended to read as follows:

"ARTICLE VI.

The stock of this corporation shall be divided into 60,000 shares of common stock of a par value of \$10.00 each."

RESOLVED FURTHER That the President and Secretary of this corporation be, and they hereby are authorized and directed to make, execute and acknowledge a certificate under corporate seal of this corporation embracing the foregoing resolutions, and to cause such certificate to be filed, recorded and published in the manner required by law.

AND WHEREAS, the Board of Directors believes it to be to the best interests of this corporation that the Articles of Incorporation be amended as recommended by the stockholders,

BE IT RESOLVED, That the resolution of the stockholders hereinabove set forth and said Articles of Incorporation so amended be, and they hereby are, duly adopted, ratified and confirmed.
