RESTATED ARTICLES OF INCORPORATION OF NORTH IDAHO COMMUNITY ACTION AGENCY, INC. 23

ARTICLE I NAME

The name of this non-profit corporation is North Idaho Community Action Agency, Inc.

ARTICLE II **PURPOSES**

The purposes for which the corporation is organized are to promote the general social welfare of the community; for those objects and purposes the corporation may develop, own, lease, or maintain a building for its members, a thrift shop, and develop, own, manage, or lease any accommodations to assist low-income people to improve their general welfare, educational, or social conditions without regard to race, color, creed, sex, or national origin; may own, manage, lease, or maintain other properties for like activities; provided, however, that this organization is formed exclusively for charitable religious, charitable educational and scientific purposes including for such purposes, the making of distributions to organizations that qualify as exempt organizations under §501(c)(3) of the Internal Revenue Code or Corresponding Section of any future Federal Tax Code.

ARTICLE VI **MEMBERS**

Members: The Corporation will have no members.

ARTICLE VII **NON-PROFIT STATUS**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article II hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on: a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code, or; b) by a corporation, contribution to which are deductible under 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE VIII DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of § 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed shall be disposed of by the district court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE IX BOARD OF DIRECTORS

The affairs of the corporation shall be managed by its Board of Directors. Amendments to the by-laws of the corporation shall be by vote of a majority of the Board of Directors. The number of directors shall be established by the by-laws.
