ARTICLES OF INCORPORATION
OF

THE ANNIE ALVIS FOUNDATION, *INC.*
(For the Unborn)

KNOW ALL MEN BY THESE PRESENTS: That we the undersigned each being a natural person and a citizen of the United States of America, hereby associate ourselves together for the purpose of forming a non-profit corporation under the provisions of Chapter 3, Title 30, Idaho Code, and do hereby adopt the following Articles of Incorporation.

ARTICLE 1

The name of this corporation shall be The Annie Alvis Foundation, *INC.*

ARTICLE 2

The term of existence of this corporation shall be perpetual.

ARTICLE 3

The registered office of this corporation shall be located in the City of Mountain Home, County of Elmore, State of Idaho and the post office address of such registered office shall be P. O. Box 834, Mountain Home, Idaho 83647. The registered agent of this corporation shall be Carrie Evans, 905 N. 6th E., P. O. Box 834, Mountain Home, Idaho 83647.

ARTICLE 4

This corporation shall issue no capital stock.

ARTICLE 5

There will be one or more classes of membership with qualifications and rights as specified in the By-Laws. The voting rights and property rights and interest of each general member shall be equal.

ARTICLE 6

The Board of Directors of this corporation shall consist of such number of persons, not less than three (3), that shall be perscribed by the By-Laws and the powers of this corporation are hereby conferred upon such directors insofar as such powers may lawfully be vested in and exercised by such a board.

ARTICLE 7

This corporation hereby reserves the right to alter, amend, change or repeal any provisions of these Articles of Incorporation in the manner now provided, or which may hereafter be provided by the laws of the State of Idaho and all rights, priviledges, and powers of these articles conferred are subject to this reservation.

ARTICLE 8

The purposes for which this corporation is formed are:

1. To promote life by providing an alternative to abortion for those contemplating terminating pregnancy.

2. To provide environments for pregnant young women in which they will have an opportunity to choose whether to keep their babies or place them for adoption.

3. To foster a program that will bring infant children, placed for adoption, together with married couples desiring to adopt such children.

ARTICLE 9

This corporation, a non-profit corporation, shall comply fully with the provisions of Section 501(c)(3) of the Internal Revenue Code of the United States of America and subsequent treasury regulations pertinent thereto. No part of the monies or assets of this corporation shall inure to the profit of any individual either during the existence of this corporation or upon its dissolution except a reasonable compensation may be paid for the performance of services for the corporation or in pursuance of the corporate purposes.

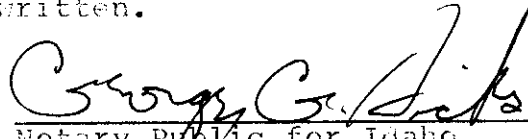
