

RESTATED ARTICLES OF INCORPORATION

Pursuant to the provisions of Section 30-1-64 of the Idaho Business Corporation Act, the undersigned corporation, pursuant to a resolution duly adopted by its board of directors, hereby adopts the following Restated Articles of Incorporation:

1. The name of the corporation is TRANSWIDE, INC.
2. The period of its duration is perpetual.
3. Its purpose is to engage in any and all business and to do all things not prohibited by law.
4. This corporation shall have a total authorized capital stock of ONE HUNDRED THOUSAND DOLLARS (\$100,000.00) divided into 10,000 shares of the par value of TEN DOLLARS (\$10.00) per share. None of such shares shall be subject to assessment.
5. The address of its registered office is 4499 Market Street, Boise, Idaho 83705. The name of its registered agent is Eardley W. Glass, Jr.
6. The board of directors shall consist of one (1) or more members as fixed by the by-laws. The number of directors constituting the present board of directors is one (1), whose name and address is:

The foregoing restated articles of incorporation correctly set forth without change the corresponding provisions of the articles of incorporation as heretofore amended, except that the wording of Paragraph 1 above was adopted by the resolution for adoption of the restated articles as an amendment to the corresponding provision of the original articles as permitted by Section 30-1-59, Idaho Code, and the foregoing restated articles of incorporation together with the designated amendment supercede the original articles of incorporation and all amendments thereto.
