KNOW ALL MEN BY THESE PRESENTS, that we, the under- $6 \, \sharp$ igned being natural persons over the age of eighteen (18) years, do hereby form a general business corporation under 8 the laws of the State of Idaho as contained in Title 30 of 9 the Idaho Code entitled "General Business Corporations Act", $oldsymbol{10}$ and to that end do hereby set forth:

- ٦. The name of the corporation is: ESCROW SERVICES, INCORPORATED
- The period of duration of this corporation shall be perpetual.
- The purposes for which this corporation is 3. 16 prganized are:
- (a) Primarily to engage in the business of acting 18 an escrow agent for real estate and commercial transactions.
- (b) The transaction of any or all lawful business 20 for which corporations may be incorporated under the Idaho Business 21 Corporations Act.
