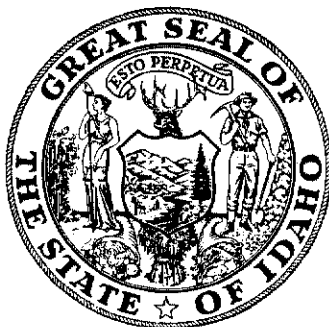

ARTICLES OF INCORPORATION

OF

HAGERMAN QUICK RESPONSE UNIT, INC.

KNOW ALL MEN BY THESE PRESENTS:

The undersigned, acting as the incorporators of a non-profit corporation ("Corporation") organized under and pursuant to the Idaho Non-Profit Corporation Act, Title 30, Chapter 3, Idaho Code ("Act"), adopts the following Articles of Incorporation for the Corporation:

ARTICLE I  
NAME

The name of the Corporation is HAGERMAN QUICK RESPONSE UNIT,  
INC.

ARTICLE II  
NON-PROFIT STATUS

The Corporation is a non-profit corporation.

ARTICLE III  
DURATION

The period of duration of the Corporation is perpetual.

ARTICLE IV  
INITIAL REGISTERED OFFICE AND AGENT

The initial registered office of the Corporation shall be located at 151 North State Street, P.O. Box 568, Hagerman, Idaho, 83332. The initial registered agent of the Corporation at the registered office is Suzanne Jensen.

## **ARTICLE V** **PURPOSES**

The Corporation is formed and created for the sole purpose of engaging in good and charitable works of a socially-beneficial nature, including, but not limited to:

- (A) The offering of emergency medical care and transportation of ill and injured citizens to medical facilities.
- (B) The advancement of the cause of medical science to the end of improving and enhancing the delivery of necessary medical services to the residents of the Magic Valley and the citizens of the State of Idaho.
- (C) To train volunteers in emergency medical and life saving techniques.
- (D) To engage in such other and further charitable and socially-beneficial works and activities which are consistent with both the purposes of the Corporation, and which are not inconsistent with the permitted purposes of non-profit corporations as set forth in the Act, or as set forth in Section 501(c) of the Internal Revenue Code of 1986, as amended.

## **ARTICLE VI** **LIMITATIONS**

Notwithstanding the generality of the foregoing article, no portion of the income or revenues of the Corporation shall inure to the benefit of any director, officer or other private person, except that the Corporation is empowered to pay reasonable compensation for services rendered or goods received, and to make distributions and payments in furtherance of its corporate purposes which are not prohibited by state or federal laws governing and regulating the powers and tax-exempt status of non-profit corporations. The Corporation shall fully comply with the provisions of Section 30-3-13, Idaho Code. No substantial part of the activities of the Corporation shall be the generation of propaganda, or attempts to influence legislation, nor shall the Corporation participate in any political campaign on behalf of any candidate for public office.

**ARTICLE VII**  
**MEMBERS**

Pursuant to Section 30-3-36, Idaho Code, the Corporation shall not have members.

**ARTICLE VIII**  
**BOARD OF DIRECTORS**

The affairs of the Corporation shall be managed by its Board of Directors. The Board shall consist of at least three (3), and no more than twenty-five (25) directors, the actual number and manner of selection of whom shall be fixed by the bylaws of the Corporation.

**ARTICLE IX**  
**DISTRIBUTION UPON DISSOLUTION**

Upon dissolution of the Corporation, and after paying or making provision for the payment of all liabilities of the Corporation, the Board of Directors shall distribute all remaining assets of the Corporation to such other organizations recognized as tax-exempt entities under Section 501(c) of the Internal Revenue Code of 1986, as amended, which the Board shall, in its discretion, determine to be most conducive to the carrying on of the Corporation's purposes as specified in these articles. Any assets not so distributed shall be distributed by the district court of the county in which the Corporation's principal office is located, exclusively to such organizations and for such purposes, as the court shall determine to be consistent with the purposes of the Corporation.
