## ARTICLES OF INCORPORATION

The undersigned, acting as the incorporators of a congression under the provision of Chapter 10% Section 30-001, Idaho Gode Alloyt the following articles of incorporation for such corporation.

FIRST: The name of the corporation is: WEISER ASSEMBLY OF GOD, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The corporation is organized exclusively for educational, charitable, religious, scientific, and literary purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code.

FOURTH: The corporation shall have all the powers granted by law necessary and proper to carry out its above-stated purposes, consistent with its qualification under Section  $501\ (c)\ (3)$  of the Internal Revenue Code.

FIFTH: In the event of dissolution, the assets of the corporation shall be distributed only to a recipient or recipients to be selected by the board of directors that would qualify for exemption as an organization described in Section 501 (c) (3) of the Internal Revenue Code of 1954, as amended, as a successor statute.
