was filed in the office of the Secretary of State on the Third day of

August, A. D. One Thousand Nine Hundred Sixty-two and is duly recorded on Film No. 120 of Record of Domestic Corporations of the State of Idaho, and that the said articles contain the statement of facts required by Sections 30-103, 30-1101 and 30-1102, Idaho Code.

AND I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name stated in the articles, and for perpetual existence from the date hereof, with its registered office in this State located at harmett in the County of Elmore and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 30, Idaho Code.

ARTICLES OF INCORPORATION

KNOW ALL MAN BY THESE PARSENTS:

That we, the undersigned, all of whom are members of the fellowship of the Hammett Community Church, Hammett, Idaho, do hereby associate ourselves together for the purpose of forming a religious corporation under the laws of the State of Idaho, in accordance with the provision of Chapter 11, Title 30 Idaho code annotated and all laws supplemental thereto and amendatory thereof, and we do hereby adopt the articles of incorporation, viz;

ARTICLE I

The name of this corporation shall be;

The Hammett Community Church Incorporated, of Hammett, Idano.

That the object and purpose for which this corporation is formed are;

- (A) To establish a church wherein the associates of this religious body may meet for worship in the manner precribed by the New Testament.
- (B) To purchase, lease or otherwise acquire, own, nold, manage, sell, lease, mortgage or otherwise dispose of real and personal property of every kind, nature and description, but said corporation shall not own or hold more real estate than is at any time necessary for the business and objects of corporation.
- (C) To receive donations and to receive, manage, take and hold real and personal property by gift, grant, demise or otherwise for the purpose herein specified.
- (D) To do everything necessary for convenient, or proper to be done in carrying out the foregoing enumerated purposed in their fullest and broadest sense without object of profit to the members of said corporation.
- (my lecuniary profit is not the object of this corporation.

The existence of this corporation shall be percetual.

ALTIULE LIL

The place where the principal place of business of said corporation shall be located, and its registered office maintained, shall be in the Community of hammett, County of Elmore, State of Idaho.

AnTiCLE IV

This corporation is organized without capital stock and no stock of any kind or nature has been or shall be hereafter issued by said corporation.

ARTICLE V

That the directors of said corporation shall consist of three (3) associates to be elected at the annual meeting of said corporation; provided, however that said number may be increased to five (5) or more by a two-thirds (2/3) affirmative vote of all members in attendance at any annual meeting voting upon said questions.

ALTICLE VI

That the annual meeting of said corporation for the election of directors and transaction of all other business of said corporation shall be held on the first honday of October of each year at the nour of detclock P.M. at the registered office of said corporation in Hammett, Idaho; that no notice of the annual meeting shall be required.

ARTICUL VII

That a meeting of the members of the hammett Communit, Church of Lammett, Idano was duly nad and held at the home of Noah Schrock, Hammett, Idaho on the 3rd day of May, 1962, for the purpose of forming this corporation and election of directors thereof; that notice of said meeting was given in the form attached hereto by the posting of a copy thereof in a conspicuous place on the building where such an election was to be held and by publication of said notice for at least two weeks in the Glenns Ferry Gazette, a newspaper of general circulation in and published in the City of Glenns Perry, Idaho.
