

ARTICLES OF INCORPORATION OF ECO TEC OF NORTHWEST AMERICA, INC.



The undersigned, acting as incorporator of a Corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such Corporation.

ARTICLE I
