# AMENDED ARTICLES OF INCORPORATION.

OF

# THE WASHINGTON TRUST COMPANY.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned citizens of the United States and residents of Spokane, Spokane County, Washington, have this day associated ourselves together for the purposes of forming a corporation under the laws of the State of Washington, and hereby certify and declare:-

#### ARTICLE I.

The Name of this corporation is THE WASHINGTON TRUST COMPANY.

ARTICLE II.

The principal place of business of this corporation shall be and is Spokane, Spokane County, Washington, and the term for which this corporation shall exist is and shall be fifty (50) years from the 23rd day of October, 1902.

# ARTICLE III.

This corporation is organized for the purpose of doing any and all business hereinafter provided for, in the State of Washington and any and all parts of the United States and in any and all parts of British Columbia.

# ARTICLE IV.

The objects and purposes for which this corporation is formed are to act as trustee for any and all kinds of property, individuals and corporations; to transact a general trust company business, a general savings bank business and safe deposit business; to act as fiscal agent for any state, municipality, person or corporation; to transfer and register bonds and certificates of stock; to serve as trustee under

any mortgage or bond issued by any corporation or person; to act as guardian, administrator, executor or receiver; to act as agent for any and all individuals and corporations in the transaction of any and all kinds of business whatsoever; to buy, own manage, control, operate, improve, develop, lease, incumber and convey any and all kinds of real and personal property; to carry on a general insurance, real estate, rental, collection and brokerage business and to carry out the objects and purposes for which this corporation is organized.

# ARTICLE V.

The capital stock of this corporation shall be fifty thousand dollars (\$50,000), divided into five hundred (500) shares, of the par value of one hundred dollars per share.

#### ARTICLE VI.

The number of Trustees of this corporation shall be three (3) and the names of those who shall manage the business thereof as Trustees for the first six months of the existence of this corporation are M. B. CONNEILY, J. GRIER LONG and R. L. WEBSTER.
