## Articles of Incorporation

Dataday Automated

FIRST. A) The name of the corporation is Dataday systemated Services. Inc.

- B) This corporation shall have a perpetual period of duration.
- C) The nature of the business and objects and purposes proposed to be transacted, promoted and carried on, are to do any and all things herein mentioned, as fully and to the same extent as natural persons might or could do, in any part of the world, viz:
- "the purpose of the corporation is to engage in; 1) Computer and management consultation; 2) Computer maintenance and repair; 3) Information and research services; 4) Any lawful service, act or activity that may pertain to automated technology and services; 5) Any or all lawful acts or activities for which corporations may be incorporated under the Idaho Business Corporation Act."
- D) The corporation shall have the authority to issue: One Hundred Thousand shares of common stock, each share to have No Par Value. The shares may be issued for the consideration expressed in dollars as may be fixed from time to time by the board of directors. Said preferred stock may be issued from time to time in one or more classes or series, with such dividend rates, voting rights, rights of conversations, rights upon dissolution or liquidation and with such designations, preferences and relative participation, optional or other special rights or qualifications, limitation or restrictions thereof, as shall be determined by resolution adopted by the Board of Directors at the time such stock is issued.
