ARTICLES OF AMENDMENT

OF

BOUNDARY COUNTY MENTAL HEALTH VOLUNTEERS, INC.

KNOW ALL MEN BY THESE PRESENTS: That on May 4, 1977, at Bonners Ferry, Idaho, at a meeting called for the specific purpose of amending the Articles of Incorporation as herein after described, at which meeting over two-thirds of all the members were present either in person or by proxy, the following amendment to the Articles of Incorporation was unanimously adopted:

That the following be and hereby is added to Paragraph Fourth:

That this corporation is organized exclusively for charitable and educational purposes, and that notwithstanding any other provisions of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provisions of any future United States Internal Revenue Law) or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).
