

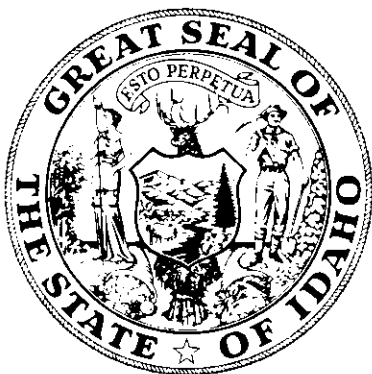

ARTICLES OF AMENDMENT OF ARTICLES OF INCORPORATION

OF

HIGHWAY EVANGELISM, INC.

Pursuant to Sections 30-326 and 30-327 of the Idaho Non-Profit Corporation Act in the Idaho Code, the undersigned corporation adopts and following Amendment to its Articles of Incorporation:

Article VIII is hereby amended to provide that the number of Directors of the Corporation, including the minimum and maximum numbers and the policy toward filling vacancies and the rules concerning majority votes shall be specified in the By-laws of the Corporation.

The above amendment was adopted at the Annual Meeting of Board of Directors of the Corporation on February 4, 1982 in which a quorum was present and in which a majority of those present approved such amendment. The above amendment was also adopted at the Annual Meeting of Members held on February 4, 1982 at which there was a quorum present in person and by proxy and at which a majority approved the above amendment. The meetings were held at 1602 Appleway, Coeur d'Alene, Idaho. There are no shareholders of the corporation and, in accordance with Idaho Code, the Articles of Incorporation were amended by the Directors of the Corporation.
