ARTICLES OF INCORPORATION

1. The name of the corporation is Language Vision, Inc.
2. The period of its duration is perpetual.
3. Its purpose is to the development and sale of speech signal visualization processing technologies and all other businesses not forbidden by law.
4. It shall have the authority to issue a total of 1,000,000 shares of no par value common and preferred stock. It shall have authority to issue 500,000 shares of no par value common stock and 500,000 shares of no par value preferred stock. Dividends on the common and preferred stock will be determined by the board of directors. The voting rights of the preferred and common will be equal, one vote for each share. The preferred stock will have priority (preference) over the common stock on distributions made in liquidation of the corporation.
5. The address of its initial registered office is 683 N. Capital, P.O. Box 51718, Idaho Falls, Idaho 83405-1718. The name of its initial registered agent at such address is Winston V. Beard.
6. It shall have a board of directors with no fewer than 5 directors and no more than 9 directors. The number of directors constituting its initial board of directors is 5.
