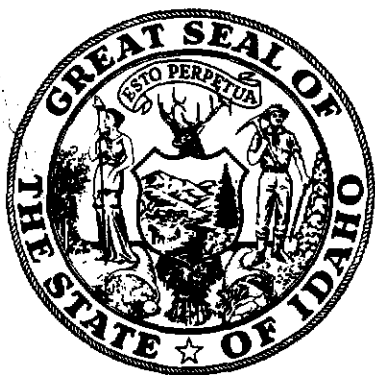

THIRD AMENDMENT TO  
ARTICLES OF INCORPORATION OF ~~Jan 19~~ 10 01 AM '90  
LEWIS-CLARK EARLY CHILDHOOD DEVELOPMENT PROGRAM, INC.  
SECRETARY OF STATE

The undersigned, as members of the Board of Directors of LEWIS-CLARK EARLY CHILDHOOD DEVELOPMENT PROGRAM, INC., hereinafter, the "Board", amends its Articles of Incorporation in compliance with Idaho Code Section 30-327 by stating the following:

1. Article IX (GENERAL PROVISIONS) is amended to read in the manner set forth below:

- a.) The Corporation shall have no capital stock.
- b.) This organization is organized exclusively for charitable and educational purposes within the meaning of section 501(c)(3) of the Internal Revenue Code. The Corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt under Section 501(c)(3) of the Internal Revenue Code and its regulations as they now exist or as they may hereafter be amended; further, upon dissolution of the corporation or the winding up of its affairs, the assets of the corporation shall be distributed exclusively to charitable, religious, scientific, testing for public safety, literacy, or education organizations which would then qualify under the provisions of Section 501(c)(3) of the Internal Revenue Code and its regulations.
- c.) All the subscribers of this certificate are of full age, citizens of the United States and residents of the State of Idaho.

2. On January 16, 1990, a majority of the members in Office adopted the amendment making the change in Article IX above indicated.
