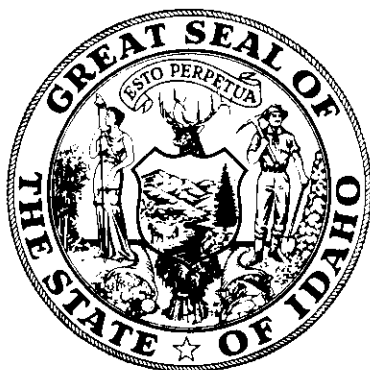

ARTICLES OF INCORPORATION
of
ROBINSON DEVELOPMENT, INC.

KNOW ALL MEN BY THESE PRESENTS:

THAT WE, the undersigned, being each full age citizens of the United States of America, and of the State of Idaho, do hereby certify that we have associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, pertaining thereto, to-wit: 30-1-3, 30-1-4, et. sec., and hereby adopt the following ARTICLES OF CORPORATION:

ARTICLE I

The name of this corporation shall be ROBINSON DEVELOPMENT, INC.

ARTICLE II

The duration of this Corporation shall be perpetual.

ARTICLE III

The object and purposes of this Corporation shall be and are as follows:

(a) To acquire, own and operate one or more 7-11 Food Store franchises, which are a division of the Southland Corporation, and in that regard to hold or occupy such buildings or other structures as is necessary to accomplish that corporate purpose.

(b) To enter into such contracts, franchise agreements, leases or other agreements necessary to carry out the purpose of operating said 7-11 food stores franchises.

(c) Power and capacity to act possessed by a natural person which acts are necessary and proper to accomplish the corporate purposes and which are not repugnant to law, including, but not limited to all powers and authorities now or hereafter conferred by the laws of the State of Idaho upon corporations formed thereunder.

(d) To purchase and reissue the shares of its capital stock according to law and in accord with franchise agreements, guarantees, assignments or any other agreements between the corporation and 7-11 Food stores, a division of the Southland Corporation. When such stock is owned by the corporation, such stock will not be considered voting stock directly or indirectly.

ARTICLE IV

The location of the registered office in this state shall be located in Nampa, Canyon County, Idaho, and the post office address shall be 1208 Heather, Nampa, Idaho 83651. The name of its initial registered agent at that address is Larry Robinson.

ARTICLE V

The total authorized number of par value shares is one thousand (1000) and their aggregate par value is FIVE THOUSAND AND NO/100 (\$5,000.00) DOLLARS. Par value is FIVE DOLLARS per share. The Corporation has not authorized the issuance of any no par value shares of stock.

ARTICLE VI

There shall be only one (1) class of stock, and it shall be designated as common stock. The shares of stock shall not be issued until payment in full has been received, and such stock shall be nonassessable stock, and the certificate shall state on its face that it is nonassessable stock, and the shareholders shall have no liability for corporate obligations. Each share of stock shall have the voting rights as now or hereafter granted by the laws of the State of Idaho relating to corporations. The Corporation's ability to issue additional shares of stock shall be limited by the terms of any agreements between the Corporation and 7-11 Food Stores, a division of Southland Corporation, and shall be limited by any agreements between the incorporators and 7-11 Food Stores, a Division of Southland Corporation. Each share of stock shall bear restrictive legends in accord with any such agreements referred in the two sentences next preceeding.

ARTICLE VII

The names and post office addresses of each of the incorporators and the number of shares of stock subscribed for by each are as follows:

ARTICLE VIII

The Corporation shall be managed by a Board of Directors which shall be governed by the by-laws of the said Corporation. The Board of Directors shall consist on not less than one (1) nor more than two (2) members. 
