Mission Statement:

Centro Familiar Cristiano (Christian Family Center, as it translates from Spanish into English) is a religious non-profit Christian fellowship church. The purposes for which the corporation is organized are:

- (1) To operate a non-profit church which will proclaim the Good News of Jesus Christ in and around Nampa, Idaho, and the very ends of the Earth, to reach the Hispanic population in the city and its surroundings by offering bilingual services in both English and Spanish, to offer a Leadership training center to equip Christians with the tools necessary to become disciples who guide others according to the teachings of the Bible, and to encourage Christians in the living of their faith in accordance with God's Word by example, teaching and exhortation.
- (2) The general purposes and powers are to have and exercise all rights and powers conferred on non-profit corporations under the laws of Idaho, or which may hereafter be conferred, including the power to contract, rent, buy or sell personal or real property; provided, however, that this corporation shall not except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the primary purpose of this corporation.
- (3) Notwithstanding any of the above statements of purposes and power, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the primary purpose of this corporation. This corporation is organized pursuant to the Idaho Non-profit Corporation Act and does not contemplate pecuniary gain or profit to the members thereof and is organized for non-profit purposes.
