ARTICLES OF INCORPORATION
OF

PEOPLE AND ANIMALS UNITED IN CHRIST, P.A.U.X. INC.

A Non-profit Corporation

The undersigned incorporators, in order to form a corporation under Idaho State's nonprofit corporation laws, adopt the following Articles of Incorporation:

This corporation is a nonprofit charitable and religious corporation and is not organized for the private gain of any person.

Article One Name of Corporation

The name of this corporation is People and Animals United In Christ, P.A.U.X. Inc.

Article Three Statement of Purpose

This corporation is organized for the purpose of the support, education and care of both people and animals in need using alternative health care, metaphysical techniques, charitable outreaches, prayer and other activities as allowed under Section 501(c)(3) of the Internal Revenue Code, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon dissolution or winding up of the corporation, its assets remaining after payment or provision of payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for religious purposes and has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code.
