The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

- 1. NAME: The name of the corporation is Hess Ready Mix, Inc.
 - 2. <u>DURATION</u>: The period of it's duration is perpetual.
