ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS: That the undersigned, for the purpose of forming a corporation under the Idaho General Business Corporations Act, Title 30, Chapter 1, Idaho Code, does hereby certify, declare and adopt the following Articles of Incorporation:

I.

The name of the Corporation is Fruitland Electric, Inc.

II.

The nature of the business, or objects or purposes to be transacted, promoted, or carried on by the Corporation is:

To engage in and transact any or all lawful business for which corporations may be incorporated under the Idaho General Business Corporations Act.

III.

The aggregate number of shares which the corporation shall have the authority to issue is 100 shares of no-par value common stock. Said shares shall be of one class only.

IV.

The Corporation is to have perpetual existence.

V.

The business of the Corporation shall be managed by its Board of Directors, each of whom shall be at least 18 years of age. The number of directors of the Corporation shall be set forth in the Bylaws and may be altered form time to time by amendment of the Bylaws in a manner not prohibited by law.
