- 1. The name of this corporation is "RIGGINS HOT SPRINGS INC."
- 2. We certify that the objects for which this corporation is formed are: To acquire, own and operate as a pleasure and health resort, the premises and property formerly held by Andrew A. Casner and Helen A. Casner in the County of Idaho, State of Idaho, including the operation of stores and to develop and improve the same; and any and all other business which may be conveniently carried on in connection therewith and in connection with the improvement, development and operation of a natural hot spring and mud baths for the improvement and maintenance of health, together with the maintenance of cottages and cabins, and provision for medical care of patrons.

To borrow money and to execute evidences of the indebtedness and to secure the payment of the same by mortgage or other hypothecation of property of the corporation.

- 3. The registered office of the corporation is at Riggins Hot Springs, Riggins, Idaho, County, State of Idaho.
- 4. The term for which this corporation is to exist is Fifty years.
