# ARTICLES OF INCORPORATION SECRETAR OF STATE

B. G. F. INTERNATIONAL INDUSTRIES, INC.

The undersigned, acting as Incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

# FIRST

The name of the corporation is:

B. G. F. INTERNATIONAL INDUSTRIES, INC.

# SECOND

The period of its duration is perpetual.

# THIRD

The purpose or purposes for which the corporation is organized and the powers of the corporation are:

- (a) The transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act, Title 30, Chapter 1, of the Idaho Code, which includes but is not limited to all those general powers as stated by law, including the right to sue and be sued, complain and defend in its corporate name, to purchase, receive, lease, and otherwise acquire, hold, improve, and use and deal with real or personal property or any investment therein, whether situated within or without the United States of America, in any foreign country.
- (b) To sell, convey, mortgage, pledge, lease, exhange, transfer, and otherwise dispose of all or any part of its property and assets.
- (c) To lend money and use its credit to assist its employees.

- (d) To purchase, take, receive, subscribe, otherwise acquire, own, hold, use, employ, sell, mortgage, lend, pledge, or otherwise dispose of, or otherwise use and deal in and with, shares or other interests in, or obligations of, other domestic or foreign corporations, associations, partnerships, or individuals, direct or indirect obligations of the United States, or any other government, state, territory, governmental district or municipality or of any instrumentality thereof.
- (e) To make contracts and guarantees and incur liabilities, borrow money at such rates of interest as the corporation may determine, issue its notes, bonds, and other obligations, an secure any of its obligations by mortgage or pledge of all or any of its property, franchises, and income.
- (f) To lend money for its corporate purposes, invest and reinvest its funds, take and hold real and personal property as security for the payment of funds so loaned and invested.
- (g) To conduct its business, carry on its operations and have offices and exercise the powers granted by this Act, within or without this state and within and without the United States of America.
- (h) To make donations for the public welfare or for charitable, scientific, or educational purposes.
- (i) To transact any lawful business which the Board of Directors shall find will be in aid of governmental policy.
- (j) To be a promoter, partner, member, associate, or manager of any partnership, joint venture, trust, or other enterprise.
- (k) To have and exercise all powers necessary or convenient to effect its purposes, which are to conduct any lawful business in any country or territory in which the corporation may be authorized to do business.

#### FOURTH

The aggregate shares which the corporation shall have authority to issue is 100,000 shares with a par value of \$1.00 per share.
