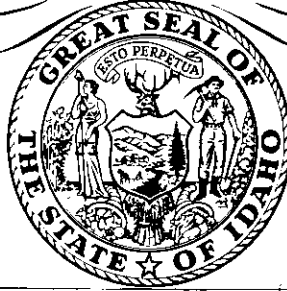

### CERTIFICATE OF INCORPORATION

I, ARNOLD WILLIAMS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho do hereby certify that the original of the articles of incorporation of

2 gage, hypothecate and to operate and generally deal in any  
3 and all kinds of lands, improved and unimproved, dwelling  
4 houses, apartments, hotels, boarding houses, business buildings,  
5 manufacturing works and plants and other buildings and struc-  
6 tures of any kind.

7 (5) To engage in the business of the accumulation and loan  
8 of money by lending the capital of the company and such other  
9 funds as it may from time to time lawfully acquire from  
10 various borrowers, upon such personal security or security of  
11 personal or real property as may be agreed upon between the  
12 corporation and the borrowers, and by re-lending in like  
13 manner the funds arising from such loans when paid; but the  
14 corporation shall not have banking or discounting privileges  
15 or powers.

16 (6) To transact the business of a real estate agent or a  
17 broker and in behalf of others to buy, sell, deal in, lease,  
18 rent and manage real estate and any interest therein.

19 (7) To engage in any commercial, industrial or agricultural  
20 enterprise calculated or designed to be profitable to this  
21 corporation and in conformity with the laws of the State of  
22 Idaho;

23 To engage in, do and perform any enterprise, act or vocation  
24 that a natural person might or could do or perform;

25 To engage in the manufacture, sale, importing and exporting  
26 of merchandise and personal property of all manner and des-  
27 cription and to act as agents for the purchase, sale and  
28 handling of goods, wares and merchandise of any kind and of  
29 all types and descriptions for the account of the corporation  
30 or as factor or agent or otherwise for and on behalf of  
31 another.

32 ARTICLE III. The duration of the corporation is perpetual.

ARTICLE IV. The location and post office address of the  
corporation shall be P. O. Box 1084, Boise, Idaho. The address of  
the corporation shall be subject to change by resolution of the  
Board of Directors at any time.


ARTICLE V. The authorized capital stock of the corporation
