ARTICLES, OF AMENDMENT OF PENTECOSTAL FELLOWSHIP, Inc

The following amendment is an addition to the original Articles of Interporation

ARTICLE X shall read:

This organization is organized exclusively for charitable and exclusively for charitable and exclusively purposes within the meaning of section 501 (c)(3) of the Internal Reference Code.

Notwithstanding any other provision of these articles, the comporation shall not carry on any other activities not permitted to be carried (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation contributions which are deductible under section 170(c)(2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the corporation, the remaining assets shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for charitable, educational, religious and/or scientific purposes and which has established its tax exempt status under section 501(c)(3) of the Internal Revenue Code.

The original ARTICLE X shall be changed to ARTICLE X1.

The foregoing amendments have been duly adopted at a meeting of Pentecostal Fellowship on 21 February 1988, in which a quorum of membership was present. Said amendments receiving two-thirds of the votes cast.
